

## **Transactions Resulting in a Debit Balance**

Effective September 1, 2019, in the event a customer transaction results in a debit balance that is not fully paid for by settlement date, the account will accrue an interest charge of the cost of funds to finance the cash due funds. This interest charge will be posted in your account.
